SOFTWARE LICENSE AGREEMENT

This licence agreement (the "Agreement") is a legal agreement between you and CANON EUROPA N.V. of Bovenkerkerweg 59, 1185 XB Amstelveen, The Netherlands ("Canon") with respect to the "PTZ CAMERA AUDIO TRACKER" software (the "Software") provided with this Agreement and its associated documentation (collectively, the "Software").

1. GRANT OF LICENSE

- 1.1. In consideration of you agreeing to abide by the terms of this Agreement, Canon grants you a non-exclusive and non-transferable license to install and use the Software ("use" shall include displaying, accessing and executing the Software) on your computer(s) for your personal use on the terms contained herein; and make a reasonable number of back-up copies of the Software in support of the permitted use, provided that all such copies include the Canon's or its licensors' copyright notice as it appears in the original copy of the Software provided to you.
- 1.2. Except as expressly provided herein, no license or right, express or implied, is hereby conveyed or granted by Canon to you for any intellectual property of Canon or its licensors.
- 1.3. The Software includes third party components. Notwithstanding anything contained herein to the contrary, terms and conditions of license for each third-party component provided by an electronic documentation with the Software apply to such third-party component.

2. RESTRICTIONS

- 2.1. You must not use, copy or reproduce the Software except as expressly permitted by this Agreement, and must not assign, sublicense, sell, rent, lease, loan, convey or transfer the Software to any third party.
- 2.2. You must not revise, modify, alter, translate or convert to another programming language, disassemble, decompile or otherwise reverse engineer the whole or any part of the Software nor permit the Software or any part of it to be combined with, or become incorporated in, any other program(s) and you shall not have any third party do so, except as expressly permitted by this Agreement and except to the extent and in the circumstances expressly permitted by laws.

### 3. OWNERSHIP

Canon and its licensors retain in all respects the title, ownership, intellectual property rights and interest in and to the Software.

### 4. COPYRIGHT NOTICE

You shall not modify, remove or delete any copyright notice of Canon or its licensors contained in the Software, including any copy thereof.

### 5. NO SUPPORT

CANON, CANON'S SUBSIDIARIES AND AFFILIATES, THEIR RESPECTIVE DISTRIBUTORS AND DEALERS, AND CANON'S LICENSORS ARE NOT RESPONSIBLE FOR MAINTAINING OR HELPING YOU TO USE THE SOFTWARE. CANON IS NOT OBLIGED TO PROVIDE UPGRADES, BUG-FIXES OR SUPPORT IN RELATION TO THE SOFTWARE.

### 6. EXPORT RESTRICTION

You represent and warrant that you comply with all export laws and restrictions and regulations of the country(ies) involved, as well as with the U.S. Export Administration Regulations, and that you shall not export or re-export, directly or indirectly, the Software in violation of any such laws, restrictions and regulations, or without all necessary approvals.

Upon termination of this Agreement for any reason whatsoever, you shall immediately destroy all copies of the Software including any Software stored on storage of any computer in your possession. In addition, Canon is entitled to exercise any contractual or legal rights or remedies it may have. Notwithstanding the foregoing, Sections 1.2, 1.3, 2 through 8, and 11 to 13 shall survive termination of this Agreement.

## 10. U.S. GOVERNMENT RESTRICTED RIGHTS NOTICE
